

## Declaration of rights and waiver

— **Note:** Riding a motorcycle or other vehicle carries a fundamental risk: I acknowledge that (a) driving and riding on a motorcycle or other vehicle involves inherent risks of serious physical impairment, irreparable disability and death; (b) my participation in such described activities and / or the handling of respective equipment to injuries or illnesses sometimes, but not exclusively, to physical impairments, diseases, muscle injuries, fractures, partial and / or full body paralysis, irreparable disability and death; and (c) driving and riding on a motorcycle or other vehicle are subject to foreseeable and unforeseeable risks and hazards. **Agreed:**
